## **Explanatory Note**

This statistical annex to the 2020 EMN Annual Report on Migration and Asylum provides an overview of relevant statistics. Part 1 was produced by the Knowledge Centre on Migration and Demography (KCMD) and compiles relevant Eurostat data for the EU and Norway organised in nine thematic areas, covering the period 2017-2020. 2020 data was not available at the time of publication for certain datasets, in which case the period 2017-2019 is covered. A 'How to Read' Guide, prepared by the KCMD, is available on the EMN website <a href="here">here</a>. Part 2 consists of complementary national data otherwise not available on Eurostat, provided by EMN National Contact Points (NCPs) in the framework of the EMN Annual Report.

Please note that the publication of this statistical annex comes later than the 2020 EMN Annual Report on Migration and Asylum due to the timeline of the publication of Eurostat data.




# Top 3 nationalities of number of first residence permits annually issued: number of permits and % of total annual permits


# First residence permits annually issued: total number and % of total population


# First residence permits annually issued by reason in 2019



# Total/first-time asylum applications; first-time asylum applications as % of total population



# Top 3 nationalities of annual number of first-time asylum applications: number of applications and % of total first-time annual applications




#### Number of first-instance asylum decisions by outcome (% of total decisions)


# Top 3 nationalities of annual number of first-instance decisions: number of decisions (% of total decisions in the country) and % of positive outcome

## Third-Country Nationals resettled: absolute number




#### Unaccompanied minors applying for asylum




Third-Country Nationals who have acquired citizenship in absolute number











<u>Note on CZ</u>: Total number of third-country nationals 'identified' as victims of trafficking in human beings is not available. In brackets there are numbers of 'presumed' victims of trafficking in human beings, who entered the Programme for Support and Protection of Victims of trafficking in human beings (only for adult persons).

The number of identified victims is just the number that were identified by the Assistance system. A person can be identified as a victim of human trafficking by other authorities as well such as Police, Border Guard, court or prosecutor during an investigation or a court proceeding.

Note on FR: Data provided include identified victims of sexual and labour exploitation. Data on labour exploitation may include overlaps. The total number of 'presumed to be victims' of labour exploitation includes persons with no information on gender/nationality. Moreover, the codes used to determine the nature of the offence do not allow to identify the form of the exploitation. Consequently, these data may include victims of sexual exploitation or forced begging for example. The number of victims over 18 years of age for labour exploitation are 239 (total), 98 (female) and 133 (male), while those under the age of 18 are 29 (total), 14 (female), and 15 (male). The total number of victims 18 years of age or older for sexual exploitation are 129 (total), 107 (female), and 22 (male), while none are recorded for under 18 years of age.

Source for labour exploitation: Central Office for Combating Illegal Employment - OCLTI, ministry of the Interior. Source for sexual exploitation: General Directorate for National Police (DGPN), Delegation for victims, ministry of the Interior. Top three countries listed as number 2 refer to sexual exploitation data while those listed as number 1 refer to labour exploitation.

Note on IE: An Garda Síochána are unable to disaggregate the statistics by form of exploitation between third county nationals and EU citizens.

<u>Note on LT:</u> Source: Ministry of Interior Note on LV: Source: Ministry of Interior

Note on NL: Numbers on victims of trafficking in human beings will be made available by the National Rapporteur on Trafficking in Human Beings in October 2021.

Note on PL: The table presents the number of third-country nationals identified as victims of human trafficking. Total number of victims identified in 2020 in Poland (including EU citizens) was 269. The total figure (269) includes third-country nationals (157) and EU citizens (112). By forms of exploitation, the statistics on foreigners are as follows: sexual exploitation (32), labour exploitation (210), other forms (27). Source: National Prosecutor's Office.

<u>Note on NO:</u> Norway does not have a national identification authority and cannot provide a total number of third-country nationals identified as victims of trafficking in 2020. The UDI decided upon a total of 36 cases concerning presumed victims of trafficking (including applications for asylum). In addition, 13 presumed victims of trafficking applied for voluntary return. These numbers do not reflect the total number of victims of trafficking receiving assistance in Norway and include EEA citizens.

**Enforced return:** Enforced return, removal refers to the situation in which the third-country national is subject to the enforcement of the obligation to return (the enforcement procedure has been launched). Definition based on Art 3.5 and 3.8 of the Return Directive 2008/115/EC.<sup>2</sup>
