## Effective and efficient approaches to migration management at EU and national level

### Invitation

#### European Migration Network (EMN)

We are pleased to invite you to join the upcoming EMN Webinar “**Effective and efficient approaches to migration management at EU and national level**” on **Friday 11 June at 11:00 – 13:00** (Central European Summer time).

The year 2020 brought about unforeseen developments, challenges, and opportunities in the areas of migration and asylum. In the face of a global pandemic, which brought the movement of people and daily life to a virtual standstill, the EU and its Member States quickly established contingency measures to maintain the functioning of their asylum and migration systems as far as possible. The devastating fire in the Moria camp in Lesbos, Greece in September 2020 brought the topic of the reception of asylum seekers in the EU once again into the spotlight. Several Member States committed to relocation, although continued efforts are needed to ensure practical implementation.

These new challenges came in addition to persisting ones. The need to **continually improve the efficiency and effectiveness of migration management systems**, including return and combatting irregular migration, has been the on-going focus of efforts of EU and national policymakers, also in light of continued irregular migration flows, despite the COVID-19 pandemic. The European Commission's new Pact on Migration and Asylum, launched in September 2020, emphasised these priorities, laying out a comprehensive and holistic approach bringing together policy proposals in the areas of migration, asylum, integration and border management. At national level, new governments brought new strategic direction, and existing governments adopted new or revised strategies and action plans, setting the groundwork for legislative and policy actions in the upcoming years.

This EMN Day 2021 will be hosted as a webinar and will serve to **launch the EMN Annual Report on Migration and Asylum 2020**. The Report outlines the most significant legislative and policy developments in the EU Member States and Norway in 2020 and identifies common trends. These include, amongst others, the impacts of the COVID-19 pandemic and the mitigating measures introduced by EU Member States and Norway to ensure their migration management systems remained as effective as possible; the role played by electronic systems and digital tools;

developments to improve efficiency for better migration management; and new partnerships and strengthened cooperation with third countries.
