

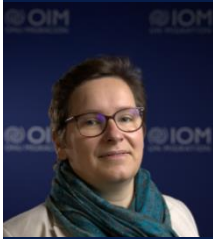

Philippe LECLERC

Director of the Regional Bureau for Europe,
United Nations High Commissioner for Refugees (UNHCR)



Philippe Leclerc is the Europe Bureau Director of the United Nations High Commissioner for Refugees (UNHCR) since 2 October 2023. He graduated in International Law in Paris in 1986 and served as Cultural Attaché for the Embassy of France in Tirana, Albania (1987-1988). He has been working for UNHCR since 1990 in various positions throughout the world (Cameroon, Bosnia-Herzegovina, Serbia, Slovenia, Belgium, Afghanistan, Syria) as well as at UNHCR Headquarters in Geneva. He also participated to many emergency missions to the field, the last of which was in the Central African Republic from December 2013 to February 2014. He was the Representative in France (2010-2015) and in Greece (2015-2020). Philippe Leclerc lastly served as the Representative in Türkiye between January 2021 – September 2023, before his assignment as UNHCR Europe Bureau Director.

Johannes LUCHNER

**Deputy Director General for Horizontal Affairs and Migration,
Directorate-General for Migration and Home Affairs, European Commission**



Johannes Luchner is an Austrian national who joined the European Commission in 1996. He holds a Master's degree from the University of Vienna and a PhD from Penn State University. Before joining the European Commission, he worked as a free journalist and in the Austrian diplomatic service. He started his career in the Commission as desk officer for development cooperation. Johannes Luchner subsequently worked in the cabinet of Vice-President Kinnock, in DG Industry and Enterprise, the DG for Civil Protection and Humanitarian Aid Operations (ECHO) as well as a Member of the Task Force for Greece in DG ECFIN. In April 2020, he joined DG HOME as Director for Strategy and General Affairs and he is now the Deputy Director General in charge of migration policy.

Lindsay JENKINS

Senior Advisor, Bureau of Population, Refugees, and Migration, U.S. Department of State



Lindsay Jenkins serves as Senior Advisor for Migration Policy in the State Department's Bureau of Population, Refugees and Migration (PRM). Her responsibilities include promoting safe, orderly, humane, and regular migration and protections for vulnerable migrants, refugees, asylum-seekers and stateless people. She also facilitates multilateral responses to the impact of climate change on migration and forced displacement. Prior to joining PRM in June 2022, Lindsay was a Protection Officer with the UNHCR office in Washington, DC, where she led policy efforts related to access to asylum, border processing and reception capacity, regional protection and solutions response to forced displacement in northern Central America, and statelessness. Before her time with UNHCR, she worked as an immigration attorney for detained asylum-seekers and torture survivors in Pennsylvania and served as a Peace Corps Volunteer in Honduras from January 2002 to June 2005. Lindsay holds a Bachelor of Arts from the University of Virginia, and a Juris Doctor and a Master's Degree in International Affairs from American University, where she was a Public Interest/Service Scholar.

Catherine NORTHING

Head of International Partnerships Division, Office of Partnerships, Advocacy and Communication, International Organization for Migration (IOM)



Catherine Northing is the Head of the International Partnerships (within the Office of Partnerships Advocacy and Communication) at the International Organization for Migration. Prior to this post she was the Chief of Mission in Sudan and also served as Deputy Chief of Mission in Yemen, as Chief of Mission in Rwanda and as Programme Manager in Afghanistan.

In her current role she leads a team that is responsible for institutional partnerships with civil society, local and regional governments, intergovernmental organizations, inter-state consultation mechanisms on migration, youth and ad interim, multilateral development banks.

Prior to IOM she worked for the UN Mission in Afghanistan (UNAMA) and with NGOs in Tanzania, Sierra Leone and UK. Catherine holds a BA in Politics and International Relations (with honours) from the University of Lancaster, and a MA in Development Studies from the University of Leeds and a post-graduate Diploma in Humanitarian Assistance from Fordham University.

Before being named Director at the Austrian Federal Ministry of the Interior, Tobias Molander was the Head of Unit responsible for Austria's Humanitarian Admission Programme as well as Austria's return policy during the EU Presidency 2018. From 2010-2015, he served as Attaché for Home Affairs at the Permanent Representation of Austria to the European Union in Brussels where he actively participated in the negotiations of several legal acts, in particular on the Common European Asylum System and border protection.

With over a decade of experience in the Rwanda National Police (RNP), she has held multiple significant positions, including Acting Director of Community Policing, Deputy Commissioner for Public Relations, Media, and Protocol, and Director of the Anti-GBV Desk. She holds a Master's degree in Peace and Conflict Transformation from the University of Rwanda, underscoring her dedication to fostering stability and security. Her extensive career reflects a commitment to public service and national development across various leadership capacities.

Souadou N'DIAYE

Technical Advisor for Migration and Refugees, Ministry of the Interior, Mauritania

Prior to this he served as Private Secretary to the Danish Foreign Minister from 2007-2008 and European Correspondent/Foreign Policy Committee Secretary.

Daniel Thym is Professor of Public, European and International Law and serves as Director of the Research Centre Immigration & Asylum Law at the University of Konstanz, Germany.
